#### LIMITED CLASS SIZE



## **WEAR UNIFORM FROM HOME**

# PICK UP AND **DROP OFF ONLY**



Class size will be capped to ensure each students are 2 meters apart

Students will be asked to come to school, ready in his/her uniform.



To minimize traffic and safety of all staff and students, parents viewing will be unavailable until further notice.

## **MODIFIED** CURRICULUM



## DISINFECT **SURFACES**



Contact sparring and other exercises that require close contact will be avoided until further notice.




There will be adequate buffer time between classes to ensure lower traffic and time for disinfection.



Before and after each class, equipment and high traffic area will be disinfected.

## **TEMPERATURE** CHECK



Temperature check will be performed to each people entering the studio using non-contact thermometer.

### HAND SANITIZER



Each person entering the studio will be asked to use hand sanitizer as they enter.

#### COMPLIANCE FORM



Students (or parents/quardian) will be asked to sign health declaration and policy compliance form.


## **AVOID USE OF** WASHROOM

Use of washrooms will be strongly discouraged unless it is absolutely necessary.



Use of facemask is encouraged. Students may bring their own.



Use of foot protection is encouraged. Students may wear Taekwondo shoes or non-slip socks.

#### Mandatory use of Mask or Face Covering within Niagara Taekwondo

#### **Background**

Beginning July 31<sup>st</sup>, 2020, all staff, visitors and customers are required to wear a mask or face covering upon entering and remaining within *Niagara Taekwondo*.

This Policy is created in compliance with Niagara Region By-Law 2020-46.

#### **Mandatory Requirements**

The mask or face covering must cover the nose, mouth and chin.

The following persons are exempted from requiring a mask or face covering and will not be required to provide proof of such exemption:

- a child who is under the age of five (5) years old;
- a person who is unable to wear a face covering as a result of a
  medical condition or a disability pursuant to the Human Rights Code,
  R.S.O. 1990, c. H.19, who is unable to put on or remove a face
  covering without assistance or for whom a face covering would inhibit
  the person's ability to breathe;
- a person while consuming food or drink provided by a business that is permitted to operate under the Provincial Emergency Orders and provided that all other conditions of the Emergency Orders are met;
- a person engaged in a sport or other strenuous physical activity;
- a person while assisting or accommodating another person with a hearing disability; and
- employees and agents for the owner or operator of the enclosed public space within an area not for public access, or within or behind a physical barrier.

Signage of this requirement will be posted on all entrance and exits of the establishment.

Failure to abide by this Policy may constitute a continuing offence or a multiple offences as set out in the *Niagara Region By-Law 2020-46*, and may be subject to penalties as stated in the *Niagara Region By-Law 2020-46* and the *Provincial Offences Act, R.S.O. 1990*.
